# **Public Educational Materials**

#### Background:

- The Department of the Army notified the Advisory Council on Historic Preservation (ACHP) by letter dated 19 Sept 2019 of its intent to seek a *Program Comment for Army Inter-War Era Historic housing (1919-1940)*
- The Department of the Army published a notice in the Federal Register (Vol 84, No 28, Oct 2019) seeking public comment regarding its intent to request a Program Comment from the ACHP for Army Inter-War Era Historic Housing (1919-1940)
- The Army Program Comment notification letter to the ACHP and the Army Federal Register notice proposed a number of preservation and treatment measures to ensure the effects of Army management actions on this historic housing are taken into account
- The Army stated that it would develop Inter-War Era housing *public educational materials* as one of its treatment measures proposed to be included in the Inter-War Era Housing Program Comment
