Hot Time in Old Town (Albuquerque): The 2008 Annual Meeting of the SHAs

Greetings from Albuquerque! The Hyatt Regency Albuquerque hosted the 41st Annual Conference on Historical and Underwater Archaeology, January 8 – 13, 2008. The conference was well attended and drew archaeological professionals from across the US, Canada and Europe. The focus for this year's conference was Public Archaeology. Presenters addressed questions on engaging the public in historic archaeology and how the public could benefit from historical archaeology. In addition, several sessions were dedicated to historic southwest archeology.

DoD was well represented with attendees from all branches of the Services. DoD participants gave two organized sessions: "Public Engagement and the Public Benefits in Army Archaeology" and "New Developments in Navy Underwater Archaeology." The Army session touched on a variety of topics including, benefits for the public and the Army using innovative adaptations of alternative mitigation and predictive modeling and using cultural and heritage sites to engage the broader DoD public. The Navy session focused on new advances including the preservation of submerged cultural resources, and identification of skeletal and dental remains of service members in a submerged context. Several other DoD attendees presented at various sessions throughout the conference demonstrating the military's commitment to archaeological compliance and stewardship.

There was also quite a bit of excitement taking place around the hotel due to scheduled filming days for an upcoming feature film. While at least one familiar face was spotted among those in costume, most of the DoD excitement surrounded the realistic "concrete" barriers and "rubble." The light, durable materials scattered around Albuquerque streets led some DoD Cultural Resources Managers to wonder if Hollywood's prop-makers have the knowledge to make In-Theater Heritage Training more realistic and challenging.

Overall, the solid presence of the DoD and exceptional sessions are sure to leave a lasting impression... much more lasting than old what's-his-name-movie-star had on us.

Where's the Article on Heritage Assets?

In the last edition of the UPDATE, DoD Deputy FPO Brian Lione promised the next article on DoD's Historic Real Property Portfolio would be about Heritage Assets. As press time for this UPDATE draws close, he has yet to turn in the information. Where's the article, Brian?

"Heritage asset reporting," notes Lione in a recent email, "is part of a much larger accountability program run by the Office of the Deputy Under Secretary of Defense - Comptroller. This program is governed by the DoD Financial Management Regulation, or FMR. The current DoD FMR has fifteen volumes and a large number of chapters within each volume." So?

"Recently DoD and the Service headquarters cultural resources representatives drafted revisions to the way all of DoD will report Heritage Assets," continued Lione. "Until those revisions are final and published, it's a little premature to send in an article about Heritage Asset reporting. I don't want to confuse anyone with talk about new reporting requirements that are not yet official." In the meantime, anyone wanting some light reading on the DoD FMR can navigate to <http://www.defenselink.mil/COMPTROLLER/FMR/>.

Volume 6B, Chapters 11 and 12, are where you'll find the old information on Heritage Assets that will be updated in the near future.

So there you have it. The Heritage Assets article is on hold until the DoD FMR is updated. SAVE THE DATE: 2008 DoD HISTORIC BUILDINGS WORKSHOP AND CONFERENCE

NPS TO RENEW ARCHEOLOGY INVESTIGATION PERMIT FORMS WITH OMB

A Permit for Archeological Investigations is needed whenever archeological investigations are carried out on Federal lands by non-Federal personnel, either as part of a development project or for research. Within the Department of the Interior, the Departmental Consulting Archeologist oversees the updating and regular review of the application form and the permit form. These forms require OMB approval, because the forms solicit information from the public.

In preparation for renewal of OMB approval, the NPS Archeology Program published a 60 day notice of intent to renew both of the forms in the Federal Register in August and invited comments from the public. No comments were received about the forms.

The NPS anticipates publishing a 30 day notice of intent to renew the forms in January 2008, in the Federal Register. Anyone wishing to comment on the forms should watch the Federal Register for publication of the notice, and send comments to the addresses within the notice.

DAYTON AVIATION INCLUDED ON TENTATIVE WORLD HERITAGE LIST

Secretary of the Interior Kempthorn announced the list of the fourteen sites to be included on the US World Heritage Tentative List. Properties on the tentative list are eligible to be considered for nomination to the UNESCO World Heritage List. Among the 14 sites are four sites related to the Wright Brothers' studies of flight in and near Dayton, Ohio. Currently managed by Wright-Patterson Air Force Base, Huffman Prairie Field looks much as it did in 1904 when the brothers tested the Wright Flyer III.

The sites will remain on the US Tentative list for at least one full year. At that time, 2009, they may move forward, reaching consideration by the World Heritage Committee in 2010. CAPE CANAVERAL LIGHTHOUSE CLOSED TO PUBLIC

The recently restored Cape Canaveral historic lighthouse is closed to visitors and the foundation that cares for it due to dangerously high levels of lead contamination. The lead most likely leached from the lead paint used to coat the structure and chemicals used to protect it from the elements. None of these products are currently in use, and the contamination is not likely due to the recent restoration. The Air Force hopes to have answers to how serious the threat may be at the beginning of February.

SCI-FI'S GHOST HUNTERS VISIT WPAFB

According to the base newspaper, "Skywriter," The Atlantic Paranormal Society (TAPS) of the weekly show *Ghost Hunters* filmed in mid-January at Wright Patterson Air Force Base in Dayton, Ohio.

The cast investigated some reports of unexplained activity in two buildings on base. The episode's air date is yet to be announced. These recent events leave open a new question to be considered: if ghosts are discovered, are they cultural resources?

NOTE: In deference to the location of the 2008 Annual Meeting of the Society for Historical Archaeologists, this month's recipe involves indigenous ingredients from the American Southwest.



SOUTHWESTERN RECIPE: Sopapillas and Red Chili Pork

Sopapillas

4 c flour
3 tbsp baking powder
2 tsp salt
3 tbsp lard

Red Chili Pork

1-2 lbs thin boneless pork loin
4 tbsp red chili powder
½ -1 c water
garlic to taste

DIRECTIONS

Mix Sopapilla ingredients together for about five minutes. Mix in enough water to make a stiff dough. Let dough set for approximately one hour. Roll dough to ¼ inch, thickness. Cut into squares. Fry in VERY hot oil, remembering the hotter the oil, the puffer the finished product. For Red Chili Pork, fry pork. Do not drain oil from pan. Add other ingredients and stir. If result is too watery, add some flour to thicken. Serve pork on warm Sopapillas topped lightly with shredded cheese, lettuce, and diced tomatoes.
