SUBJECT: Updated Goals for the Defense Environmental Restoration Program (DERP)

After a thorough review and analysis, of the existing goals, conducted in partnership with your staff, this memorandum establishes updated DERP goals. These updated goals reflect the maturation of the DERP, further enabling the DoD Components to advance sites through the final phases of cleanup to site closeout. These goals will also enable the department to demonstrate overall program progress in a more streamlined, transparent fashion. The updated DERP goals are:

- 95% of Installation Restoration Program (IRP) sites and Building Demolition/ Debris Removal (BD/DR) sites at active installations and Base Realignment and Closure (BRAC) installations will achieve remedy in place by the end of Fiscal Year (FY) 2014.
- 90% of IRP sites, BD/DR sites, and Munitions Response Sites (MRSs) at active installations and BRAC installations, and IRP sites and BD/DR sites at FUDS properties will achieve response complete (RC) by the end of FY 2018.
- 95% of IRP sites, BD/DR sites, and MRSs at active installations and BRAC installations, and IRP sites and BD/DR sites at FUDS properties will achieve RC by the end of FY 2021.
- By the end of FY 2014, 95% of MRSs reported to OSD on active installations, BRAC installations, and FUDS properties will have either: 1) a numeric Munitions Response Site Prioritization Protocol score from 1 (the highest) to 8 (the lowest) that indicates an MRS's relative priority for response actions; 2) an alternative rating of "no longer required" – a determination that the MRS no longer requires an assigned priority because DoD has conducted a response, DoD has met all objectives set out in the decision document for the MRS, and the MRS requires no further action except for long-term monitoring and recurring reviews; or 3) an alternative rating of "no known or suspected hazard" – a determination that an MRS has no known or suspected hazards.

These updated goals are effective immediately and apply to sites funded under the DERP. However, the goals do not apply to sites on a Formerly Used Defense Sites (FUDS) property


where an individual or company has been identified as being potentially responsible for or having contributed to the contamination.

The DoD Components shall continue to plan, program, and budget accordingly during future budget submission cycles to meet the updated goals. The goals, while not legal requirements in themselves, are required to facilitate the DoD Components' efforts to meet their legal requirements. The goals impose no new cost requirements as they are based on current program implementation and cost projections to meet legal obligations.

These updated goals supersede the goals listed in: 1) *New Goals for the Defense Environmental Restoration Program (DERP) Memorandum* (July 18, 2011); 2) the Table in Enclosure 3 of DoD Manual (DoDM) 4715.20, *Defense Environmental Restoration Program (DERP) Management* (March 9, 2012); and 3) *Military Munitions Response Program (MMRP) Goal – Evaluation Pending Memorandum* (November 15, 2012).

Attachment 1 outlines the updated DERP goals, which OSD will include in the next update of DoDM 4715.20. Attachment 2 includes the goals that no longer apply. OSD will reevaluate the updated DERP goals in FY 2016 to determine if they are still realistic and achievable.
