Appendix A: Environmental Management Systems

Environmental Management Systems

An environmental management system (EMS) is a formal framework for integrating the consideration of environmental issues into the overall management structure that, when properly implemented, identifies the environmental aspects of the mission; highlights and prioritizes areas of risk; promotes pollution prevention; and tracks progress toward environmental goals. It is a dynamic, proactive, and adaptable management system that provides a logical, step-by-step process for integrating environmental issues into the overall operating structure. The Department of Defense (DoD) implements EMSs to improve operational efficiency while reducing environmental risk and associated costs.

Executive Order (E.O.) 13148, issued April 20, 2000, entitled "Greening the Government through Leadership in Environmental Management," directed each federal agency, including DoD, to integrate environmental accountability across all missions, activities, and functions into day-to-day decision making, long-term planning, and processes. At a minimum, E.O. 13148 required that each Component implement a documented EMS at all appropriate facilities by December 31, 2005.

In response to E.O. 13148, the Under Secretary of Defense (Acquisition, Technology, and Logistics) issued the DoD EMS policy memorandum in 2002, recognizing the different missions within DoD and providing support for each Component to implement an EMS that best fits its mission needs.

In Fiscal Year (FY) 2006, the Components made significant progress in implementing EMSs, while meeting the E.O. 13148 deadline through DoD's six implementation metrics. EMSs are in place at all DoD appropriate facilities and operational improvements are already evident. The EMS at the Defense National Stockpile Center resulted in the development of an alternative use for excess manganese ore, avoiding over \$1 million in

disposal costs. Senior leaders are actively engaged in the implementation and continued operation of the EMS.

On September 22, 2006, DoD deployed new EMS metrics; "EMS Metrics for Fiscal Years 2006 through 2008," for the appropriate facilities. The metrics are based on the federal EMS metrics and include both annual and semi-annual reporting requirements. The new DoD EMS metrics continue to drive implementation, and the Department has begun to use them to assess the progress, performance, and successes of EMSs already in place.

Compliance with Executive Order 13148

In FY2006, each Component maintained a list of appropriate facilities that are required to implement an EMS. A consolidated list of these facilities is located at the end of this appendix. The Department also continued to track facility-level progress using the following EMS implementation metrics:

- Policy—Facilities issue an EMS policy statement
- Self-Assessment—Components perform a gap analysis against an accepted EMS framework
- Plan—Components prepare an EMS implementation plan, including dates, resources, and responsibilities
- Aspects—DoD Components identify, document, and prioritize their environmental aspects
- Training—Facilities conduct awareness-level EMS training
- Review—Facilities perform at least one management review in accordance with the installation's documented procedure for recurring EMS management reviews.

EMS Guidance

DoD provided EMS implementation guidance to the Components in the DoD EMS policy memorandum dated April 5, 2002. The policy requires Components to comply with E.O. 13148, as well as specific minimum elements. Under the guidance, Components:

- Shall adopt an EMS that best suits its needs and integrate the EMS into all core business areas
- May adopt International Organization for Standardization (ISO) 14001 Environmental Management Standards
- Should pursue third party registration only when it provides a clear and documented benefit
- Are encouraged to implement a complementary management system for safety and occupational health.

Providing additional EMS implementation guidance to installations and ranges is the responsibility of the Components, as indicated in the following statement from the DoD policy, "Recognizing the diversity of our missions, each DoD Component shall implement an environmental management system that best suits its mission needs." In FY2004, DoD also issued EMS implementation metrics to track the progress of EMS implementation across the Department.

On January 27, 2004, the Office of the Federal Environmental Executive (OFEE) formally issued the Environmental Management System Agency Self-Declaration Protocol for Appropriate Federal Facilities (EMS Protocol). The EMS Protocol, which was developed by the E.O. 13148 Interagency Environmental Management Workgroup, required federal agencies and bureaus to establish their own procedures for EMS self-declaration by December 31, 2004.

To meet this requirement, the Department issued the DoD EMS Self-Declaration Policy on July 16, 2004. Components developed and finalized their specific self-declaration procedures. Installation commanders must use the Component-specific self-declaration procedures to determine whether they have fully conformed to requirements for implementing an EMS and can credibly state that they have an EMS in place. DoD considers an EMS to be

in place if a facility fulfills the six DoD implementation metric requirements and has self-declared according to the Component-specific self-declaration protocol. A facility's EMS is regarded to be fully conforming when it meets all the requirements of the Component-specific EMS policy.

EMS Implementation Progress by DoD Component

The Components are developing and issuing EMS guidance to assist appropriate facilities in implementing EMSs that will efficiently meet their needs and mission requirements.

Army

The Army continues to progress towards meeting DoD EMS goals and requirements. In FY2006, the Army reduced its list of appropriate facilities for EMS implementation from 169 to 166 due to Base Realignment and Closure (BRAC). The 417th BSB Wuerzburg Kitzingen, Germany, which included both Giebelstadt and Wuerzburg, was removed from the appropriate facility list due to closure. The Charles E. Kelly Support Facility and Fort McPherson are also scheduled to close under BRAC 2005.

As of December 31, 2005, all appropriate facilities have met the requirement to have an EMS in place as defined by the six DoD metrics. Army policy states that all appropriate facilities will have a mission-focused, installation-wide EMS that conforms to ISO 14001, in place by September 30, 2009. All Army facilities are on track to meet this goal. Approximately 29 Army appropriate facilities report that they have already achieved this goal and two have been verified by external Army (second party) audits. Additionally, the Army has seven appropriate facilities that have received third party certification for their EMS.

The Army employs an incremental approach to EMS implementation, with internal milestones to meet the six DoD metrics, and have full conformance with the ISO 14001 by 2009. The interim milestones were established to set clear goals for installations and to track EMS implementation progress at appropriate facilities.

Army leadership is committed to ensuring that all appropriate facilities meet EMS requirements and encouraging continual improvement through the sharing of lessons learned. By coordinating frequent senior leadership in-process reviews, the Army provides targeted feedback to the Army Installations Management Command and Army Commands (formerly Major Commands). The Army also maintains a strong leadership focus on ensuring that installations build systems around the installation's core mission and on integrating EMS with Army's Sustainability Initiative. This leadership focus worked well in FY2005 and FY2006, contributing to improvements in Army's implementation status and continuing to lead appropriate facilities towards both mission enhancing and ISO 14001 conformant systems.

Navy

The Navy issued its EMS policy to ensure compliance with E.O. 13148 at Navy appropriate facilities on December 6, 2001. The Navy's EMS Implementation Policy and Self-Declaration Protocol, issued in FY2005, established an incremental approach to implementation that fully conformed to EMS requirements. The Navy is on track to fully conform with EMS by the end of FY2009. Currently, the Navy has 109 appropriate facilities, with five obtaining third party EMS certification. In addition, three of these Navy facilities also participate in the U.S. Environmental Protection Agency's (EPA's) Performance Track Program.

The Navy's EMS is based on the ISO 14001 model, which employs a cycle of policy, planning, implementation and operation, evaluation and corrective actions, and management review. Navy's EMS goal is to continually improve environmental performance. A fully implemented EMS will provide for continual improvement in environmental management and enhance the Navy's overall mission performance.

The Navy tasked the Commander, Navy Installations (CNI) to ensure that all appropriate installations implement EMSs in compliance with E.O. 13148. CNI is fully committed to ensuring these requirements are met and to ensure the best use of EMS as a business practice to improve uniformity, efficiency, and shore installation management. Regional Commanders and Installation Commanding Officers utilize EMSs to address activities critical to mission execution and to manage related environmental aspects to sustain operational readiness.

The Navy provides installations and regions with tools, templates, and training to assist with EMS implementation efforts. The Navy's EMS Web site, http://141.156.28.142/ems/index.html, is designed as a clearinghouse for EMS resources and provides the most comprehensive, current, and pertinent EMS information available to both Navy and other federal personnel, contributing to the successful implementation and maintenance of a facility's EMS.

Marine Corps

Headquarters Marine Corps (HQMC) issued policy on March 3, 2004, that defined the Marine Corps EMS and associated applicability, implementation criteria, and reporting requirements. HQMC subsequently published additional policy on Marine Corps EMS conformance and self-declaration on December 29, 2004. This policy requires all Marine Corps and Marine Forces Reserve appropriate facilities to fully conform to the Marine Corps EMS Policy requirements by December 31, 2007, and for all active and reserve tenant commands to fully support their host facility in attaining and maintaining conformance with their EMS. The Marine Corps policy also provides guidance in the form of an "EMS Conformance Guide" to be used for evaluating, certifying, self-declaring, and reporting conformance with the Marine Corps EMS.

The December 2004 policy also integrated audits to evaluate EMS conformance into the established Marine Corps Environmental Compliance Evaluation Program. This policy establishes September of each year as the annual reporting deadline for the results of each installation's annual EMS self-audit. In FY2005, HQMC developed EMS Lead Auditor training for personnel who would be performing the annual EMS self-audits. Courses were offered in 2005 and 2006, and HQMC will continue to provide the course annually.

In FY2006, the Marine Corps began development of the Marine Corps EMS Portal for day-to-day, installation-level EMS management. The first phase of this Portal is planned for initial operational capability in Spring 2007.

Air Force

In FY2005, the Air Force issued a self-declaration policy outlining 28 steps for appropriate facilities to have an EMS in place and 45 steps to have EMS

in conformance. Facilities would not be able to declare meeting E.O. 13148 requirements unless the local senior leader signed the self-declaration. To assist the Air Force with accomplishing training, the Deputy Chief of Staff, Installations and Logistics, issued a policy memo requiring all Air Force personnel to receive EMS Awareness Training by June 30, 2006. Additional training was made available through the Air Force Institute of Technology.

At the conclusion of FY2006, the Air Force had 174 appropriate facilities, with all 174 having implemented an EMS. All Air Force appropriate facilities have met the minimum Air Force policy criteria and have an EMS in place. Additionally, 87 facilities have declared full conformance with Air Force EMS policy, while 27 facilities have had their EMS audited by a second party. Two facilities have been accepted into EPA's National Performance Track Program, and four are participants in a state-level recognition program. The Air Force anticipates having all EMSs certified by an external party by the end of FY2009. In addition, the Air Force is moving towards combining the aspects of its EMS with a management system for safety and occupational health to create an integrated Environment, Safety, and Occupational Health Management System.

Defense Logistics Agency

The Defense Logistics Agency (DLA) continues to be a leader among federal agencies in EMS implementation. In FY2006, members of the DLA EMS Team received special recognition from the Office of the Secretary of Defense for exceeding the Department's EMS implementation goals one full year ahead of schedule. DLA's comprehensive training curriculum was specifically recognized. While comprised of tools and templates that were tailored to the DLA mission, the curriculum was structured in a manner that enabled other Defense and federal agency-wide components to use these materials. The DLA EMS Team validated their mission-focused EMSs at 100 percent of qualifying DLA activities by December 2005 through tabletop reviews, EMS implementation manuals, and documentation.

In early 2006, DLA began planning the execution of EMS on-site verification reviews. A core group of experts from DLA, its support contractors, and the U.S. Army Center for Health Promotion and Preventive Medicine was established. The team developed verification processes and conducted reviews at two DLA "pacesetter" sites—Defense Reutilization and Marketing Service Centralized Demil Center Anniston, Alabama, and Defense Supply Center

Columbus, Ohio. The review findings identified areas of strength, areas of non-conformance requiring corrective action, and procedures for follow-up actions. DLA plans to conduct on-site verification reviews at eight additional sites in FY2007, and anticipates conducting the remainder of the reviews by the end of FY2009.

DLA developed internal reviewer qualification requirements that emphasize consistency in review techniques to ensure sustainability of each EMS as a cost-effective way of doing business while meeting mission requirements. DLA also developed a program to train the personnel responsible for conducting organizational internal EMS reviews. To date, DLA has provided EMS Internal Verification Review Training to 56 DLA personnel at 3 locations.

Installations with an EMS in Place

All DoD U.S. appropriate facilities have an EMS in place as of October 1, 2006. Figures A-1 through A-6 list the appropriate facilities by Component, and the EMS in place indicator. For a facility to identify they have Self Declaration (S), the facility must complete the six DoD metrics and implementation criteria. A second party audit (2nd) is an EMS audit conducted by a trained EMS auditor, independent of the facility being audited. Third party registration (3rd) is an EMS audit conducted by the American National Standards Institute and the American Society for Quality National Accreditation Board accredited, independent registrar. EPA Performance Track (PT) is a partnership that recognizes exceptional environmental performance among participating U.S. facilities. Facilities are also recognized if they participate in a state EMS incentive program (ST).

DoD-State Partnerships

DoD recognizes the importance of sustaining solid partnerships with states to maintain public confidence in military environmental stewardship and streamline day-to-day operations. The Department considers EMS implementation to be a unique opportunity to establish and improve these partnerships. During FY2006, DoD continued its involvement in the OFEE-led federal-state initiative to advocate EMS as a tool to improve environmental performance. DoD is also leading the E.O. 13148 EMS Sub-Work Group Task Force on Collaboration with States and External Groups, which

coordinates with the Multi-State Working Group and the Environmental Council of the States to advance the use of EMSs.

EMS Funding

Each DoD Component identified resources for EMS implementation consistent with DoD EMS policy requirements. DoD's general approach to EMS implementation involves programming funding for training and EMS implementation for the current year and beyond. EMS training and implementation resources have been programmed as part of the Components' overall training and management budgets, and each Component has identified an EMS program manager. With this structure, the Department reached the goal of having EMSs in place at all appropriate facilities by December 31, 2005.

EMS Training

Leadership within DoD consistently and actively communicates and reinforces key elements of EMS policy and its impact on the mission. This active communication effectively spreads the message of the strong correlation between EMS, sound environmental stewardship, and mission performance. DoD teamed with EPA to provide EMS implementation courses for audiences including federal interagency groups, DoD groups, and the U.S. Department of Agriculture. DoD, through the Inter-Service Environmental Education Review Board, initiated a review of common EMS training requirements, available training courses, and materials. Each Component makes training materials available in various formats for the target audience, including senior leadership. Examples of training materials include fact sheets, Web-based training modules, and videos.
