Background

- As a proposed treatment measure for the Inter-War Era Housing Program
 Comment, Army has specified that it will identify Inter-War Era housing that may
 be of particular importance (see Federal Register Vol 84, No 28, Oct 2019)
- Army has extensive documentation for its Inter-War Era housing see *Technical Documents at https://denix.osd.mil/army-pchh/home/, including detailed historic contexts, original plans and designs of the housing, whole neighborhood designs, historical landscape plans at the individual housing unit and at the neighborhood levels, and overall installation design, layout, and history of planned development*
- The Army's extensive documentation of Quartermaster Corps' standardized plans used to construct Inter-War Era Housing indicates that no known significant architects or firms were involved in the design of this housing

Identification of Inter-War Era Housing of Particular Importance

- Inter-War Era Housing of particular importance is, for the purpose of this
 Program Comment, defined as: Inter-War Era housing units that are
 designated by the National Park Service (NPS) as a National Historic
 Landmark (NHL), or that are designated by the NPS as a contributing property
 in a NHL District
- Army Inter-War Era NHL listed housing units currently indicated:
 - West Point, NY 206 NHL listed Inter-War Era housing units
 - Fort Myer, VA 6 NHL listed Inter-War Era housing units
 - o Fort Shafter, HI − 1 NHL listed Inter-War Era housing unit
- There are no known Army Inter-War Era housing units that are designated by NPS as an individual NHL, all Inter-War Era housing units listed as NHLs are designated as a contributing property to a NHL District

Preservation and Treatment of NPS Designated NHL Inter-War Era Housing Units

- Army intends to review its NHL documentation to re-confirm Inter-War Era
 Housing currently indicated as NHLs / contributing properties to NHL Districts
- Army intends to continue managing adverse effects to NPS designated NHL Inter-War Era housing units under the terms of existing Section 106 agreements rather than under the terms of the Program Comment
- Army will specify in the Program Comment that NPS designated NHL Inter-War Era housing units will not be subject to the terms of the Inter-War Era Housing Program Comment
- Army FPO will issue an Army policy memorandum at the time the Program
 Comment is approved by the ACHP specifying that installations will continue
 managing adverse effects to NPS designated NHL Inter-War Era housing
 units under the terms of existing Section 106 agreements rather than under
 the terms of the Program Comment
