




# Why ICS?

- Imagine disaster at your work place.
- Imagine migration beyond your boundaries.
- Suddenly "unwanted relatives" appear:
  - EPA, OSHA, CG, FEMA, Police, Fire Dept, Public Health Service, Lawyers
- Need "System"
  - Common to everyone
  - Forces all to use common language
  - Unifies goals & objectives
  - Provides clear lines of communications.

#### SAFETY OFFICER (IMH pg 7-6):


- Develop & recommend measures for assuring personnel safety
- Assess and/or anticipate hazardous and unsafe conditions
- 1 SO per incident ... may have assistants
- Participate in planning meetings, develop site safety plan, review/approve medical plan, investigate accidents, maintain Unit/Activity log
- Exercise emergency authority to stop and prevent unsafe acts



## SO Responsibilities

- Anticipation, Recognition, Evaluation, Control of I Hazards
- Authority to stop all operations for imminent danger
- Write and enforce Site Safety Plan
- Ensure regulatory compliance
- Review Incident Action Plans for Safety Requirements
- Provide accident investigation
- Conduct monitoring
- Write safety messages
- Other?





## WMD Approach

- WMD is just Hazmat with Attitude and Intent
- Hazmat Response Protocols

- HAZWOPER is foundation WMD is just a delta on top of that foundation

U.S. COAST GUARI

Policy Statement:

In accordance with the Incident Management Handbook (IMH), Safety and Environmental Health (SEH) personnel will serve on the Command Staff as Safety Officers, members of the Safety Officer's staff, or in safety-related roles in subordinate organizations (e.g., sections, branches, divisions, groups or units) of the ICS; they will ensure the response is conducted safely and provide safety training for participating Coast Guard personnel, other organizations' personnel, and the public.
