#### SPOTLIGHT STORY

#### Long-Chain Perfluoroalkyl Carboxylate and Perfluoroalkyl Sulfonate Chemical Substances (Final)

EPA has finalized a TSCA significant new use rule for several for long-chain perfluoroalkyl carboxylate (LCPFAC) chemical substances.

This final rule requires persons to notify EPA at least 90 days before commencing the manufacture (including import) or processing of these chemical substances for the listed significant new uses in commercial and consumer products. The rule removes the "article exemption" from notification requirements for persons who import the chemical substance as part of an article (such as surface coating on apparel, outdoor equipment, automotive parts, carpets, furniture, and electronic components). Products such as paints and coatings, lubricants, and fire-fighting foam are not articles.

CLEARED coatings, lubricants, and fire-fighting foam are not articles. Perfluoroalkyl sulfonate chemical substances degrade ultimately to perfluoroalkylsulfonic acid (PFASA). While most studies of perfluoroalkyl sulfonate chemical substances to date have focused primarily on perfluorooctane sulfonate (PFOS), structure-activity relationship analysis indicates that the results of those studies are applicable to the entire category.

EPA also expects ongoing uses of other LCPFAC chemicals substances to decline because the manufacture and processing for those uses have declined or ceased.

### NATURAL AND CULTURAL RESOURCES

#### Listing Neuse River Waterdog and Carolina Madtom, and Designations of Critical Habitat (Proposed)

The Fish and Wildlife Service (FWS) is extending the comment period and revising their proposal to list two North Carolina species, the Neuse River waterdog, as threatened, and the Carolina madtom, as endangered. The Neuse River waterdog is an aquatic salamander. The Carolina madtom is a freshwater fish.

In total, FWS now proposes to designate approximately 779 miles (1,254 kilometers) in 18 units in North Carolina as critical habitat for the Neuse River waterdog.

FWS proposes to revise the downstream portion of Unit 17 (previously Unit 16) to remove 1.1 miles (2 km) of the Trent River that borders the Marine Corps Air Station Cherry Point Oak Grove Outlying Landing Field (OLF) based on the Neuse River waterdog being included in the Station's integrated natural resources management plan.

As noted in the original proposal, FWS identified the Seymour Johnson Air Force Base (SJAFB) located in Goldsboro, NC within the proposed critical habitat designation that consists of DOD lands with a completed, Service-approved INRMP. Because conservation efforts identified in the INRMP will provide a benefit to the Neuse River waterdog, streams within this installation are exempt from critical habitat designation.

### AIR

### Extension of the Laboratory and Analytical Use Exemption for Essential Class I Ozone-Depleting Substances (Proposed)

EPA is proposing to indefinitely extend the laboratory and analytical use exemption for class I ODS in 40 CFR 82.8(b)

In November 2019, ... the Parties (to the Montreal Protocol) agreed to "extend the global laboratory and analyticaluse exemption indefinitely beyond 2021, without prejudice to the parties deciding to review the exemption at a future meeting." The Decision also encourages parties to further reduce their production and consumption of ODS for laboratory and analytical uses and to facilitate the introduction of laboratory standards that do not require such substances.

EPA's proposal would make the laboratory and analytical use regulatory exemption indefinite unless or until it is limited or eliminated through future rulemaking.

Comments are due 6 October 2020.

**Review of the Ozone National Ambient Air Quality Standards (Proposed)** EPA has finalized their review of the air quality criteria and the national ambient air quality standards (NAAQS) for photochemical oxidants including ozone (O3). EPA is proposing to retain the current standards, without revision.

The last review of the O3 NAAQS, completed in 2015 established the current primary and secondary standards (80 FR 65291, October 26, 2015). In that review, the EPA strengthened the primary and secondary standards by revising both standards from 75 ppb to 70 ppb and retaining their indicators (O3), forms (fourth-highest daily maximum, averaged across three consecutive years) and averaging times (eight hours).

Comments are due 1 October 2020.

#### House Bill 7822 and Senate Bill 4357 Public Health Air Quality Act of 2020 (Draft)

A bill to protect clean air and public health by expanding fence line and ambient air monitoring and access to air quality information for communities affected by air pollution; to require immediate toxic air monitoring at the fence line of facilities with pollution linked to local health threats; to ensure the Environmental Protection Agency promulgates rules that require fence line air monitoring in communities with air polluting industrial source categories; to expand and strengthen the national ambient air quality monitoring network; to deploy air sensors in communities affected by air pollution.

Notice of Final Determination — General Permit for Discharges from Tanks, Pipes, Other Liquid Containment Structures, Dewatering Activities, and Groundwater Remediation The Department of the Environment has reissued the State/NPDES (National Pollution Discharge Elimination System) permit 11HT (NPDES No. MDG67) as the new 17HT. The 11HT permit's full title was the General Discharge Permit from Tanks, Pipes, and Other Liquid Containment Structures. The 17HT will be known as the General Discharge Permit from Tanks, Pipes, Other Liquid Containment Structures, Dewatering Activities, and Groundwater Remediation. The 17HT permit applies to discharges of wastewater from hydrostatic testing, potable water systems, construction dewatering, groundwater remediation, flushing of fire control systems, and tank bottoms, and stormwater from storage tank containment structures in the state of Maryland.

**Regulations for the Enforcement of the Endangered Plant and Insect Species Act** The Department of Agriculture and Consumer Services has adopted rulemaking to amend the lists of endangered and threatened plant and insect species by (i) removing from the regulation a plant species that is no longer globally rare, and (ii) adding to the endangered and threatened lists certain plant and insect species that are considered in danger of extinction or that are likely to become endangered in the foreseeable future throughout all or a significant portion of their native range. Effective 20 August 2020.
